Generation One

1. Gaetano¹ d'Arco was born around 1833 at Naples, Naples, Campania, Italy.¹ He married **Giuseppa Castaldo**, daughter of Ambrogio Castaldo and Gelsomina Guadagno, on 2 January 1863 at Acerra, Naples, Campania, Italy.² He died 18 August 1907 at Acerra, Naples, Campania, Italy.³

Gaetano D'Arco was a foundling and his parents were unknown. In Naples, an infant would be dropped off at a foundling home by being placed on a platform and then a wheel was turned and a bell would ring when the infant was moved to the inside of the building. The child would be baptized and then given to a wet-nurse. In Acerra records, the foundlings often came from Naples and would remain with the foster family. The foster parents' names would usually appear on the birth, marriage, and death records.

This was not the case for Gaetano d'Arco. His marriage record states "Proietto dell'Annunciata di Napoli" which means he was a foundling probably raised at the orphanage called Casa Santa Dell'Annuniziata in Naples.⁵

When his first child was born, Gaetano D'Arco was working as a farm hand, by the time of his death, he was listed as a farmer.⁶

Known children of Gaetano¹ D'Arco and his wife Giuseppa Castaldo, were as follows:

- i. Andrea² d'Arco was born on 1 May 1864 at Acerra, Naples, Campania, Italy.⁷ He probably died before 1876 at Acerra, Naples, Campania, Italy because a child with the same name was born that year, but a death record was not found during a search of both the civil and church records. It was common that when a child died, the name would be given to the next child with the correct gender.⁸
- 3 ii. Ambrogio d'Arco was born about 19 April 1866 at Acerra, Naples, Campania, Italy. The 1866 civil birth records are not available online, but since baptisms were performed shortly after birth, Ambrogio d'Arco was probably born on or not long before he was baptized on 19 April 1866. He died on 8 January 1868 at Acerra, Naples, Campania, Italy. 10

8 vii. Ambrogio d'Arco was born on 8 July 1882 at Acerra, Naples, Campania, Italy. ²² Ambrogio d'Arco, a cultivator, arrived in New York on 16 March 1905 on the *S.S. Germania*. ²³ He was traveling with Gennaro Marzullo and they were both heading to stay at 139[129?] Living[?] Street in Chicago, Illinois. ²⁴ Ambrogio d'Arco married Raffaela Ariola, the daughter of Benedetto Ariola and Giuseppa Ambrosini, on 24 February 1907 at Chicago, Cook, Illinois. ²⁵ Later, Raffaele Casalino came to visit his "cousin" Ambrosio d'Arco in Chicago. ²⁶ Raffaele was married to Ambrogio's sister Maria.

Generation Two

5. **Maria**² **d'Arco** (Gaetano¹) was born 14 May 1871 at Acerra, Naples, Campania, Italy.²⁷ She married **Raffaele Casalino**, son of Biaggio Casalino and Giuseppa Romano, on 3 August 1890 at Acerra, Naples, Campania, Italy.²⁸ On their marriage record, they are both listed as being peasants.²⁹ Life in Acerra was hard, of the five known children, two survived to adulthood.

Known children of Maria² d'Arco and Raffaele Casalino were as follows:

He filed a declaration of intention to become a citizen of the United States on 1 December 1923 where he said he arrived in New York around 26 March 1905 on the vessel *Giulio*. However the 1920 U.S. census said he arrived in 1909, and the ship manifest

for the *Ancona* lists Giuseppe D'Arco, age 35, from Acerra, the husband of Giovanna of Acerra, as arriving on 23 March 1909. The family was living at 617 Miller Street, Chicago, Cook, Illinois, near the center of Chicago's "Little Italy" Little Italy was also known as the "Near West Side" and was where most of the 1880-1914 immigrants from the Naples area settled. To was working for the railroad. In 1930, the family was renting a home at 1019 Harrison Street (probably current day West Harrison Street), Chicago, Cook, Illinois. He was widowed and living with his daughter Antoinette Darco and Josephine Porcelli, her husband, Patsy Porcelli, and their daughter. On the census record, Rose was listed with the Porcelli surname in error but correctly identified as Joseph d'Arco's daughter.

Giuseppe's wife, Giovanna Tuccillo had died in 1929, and Giuseppe married **Teresa Falco** the widow of Michael Amato on 17 November 1932.⁵² Giuseppe and Theresa had a son in 1933 who died at eight months.⁵³ It is not clear where Giuseppe was during the 1940 census. He was not living with Teresa who was listed as Teresa Amato, widowed, living with her six children at 721 Miller Street in Chicago, the youngest child being the son of Giuseppe d'Arco and listed as Amato in error.⁵⁴ But the couple were back together in 1950.⁵⁵

When Giuseppe d'Arco died on 17 June 1953 at Chicago, Cook, Illinois, he was buried in the same plot as his first wife, Giovanna Tucillo and his young son from his marriage with Teresa Falco. ⁵⁶ Giuseppe had bought the plot in Section D, Block 6, Lot 30 of the Mount Carmel Catholic Cemetery in Hillside, Cook County, Illinois on 17 March 1929, about a month after Giovanna had died. ⁵⁷ She was interred on 22 March 1929, the child was buried on 29 May 1934, and Giuseppe was interred on 20 June 1953. ⁵⁸ Teresa (Falco) (Amato) d'Arco died thirty-one years after Giuseppe and was buried as Theresa Amato with her first husband Michele Amato in Section 25 of the same cemetery. ⁵⁹

10. Biagio³ Casalino (Maria² d'Arco, Gaetano¹), was born around 27 April 1895 at Acerra, Naples, Campania, Italy. He he traveled to the United States in 1913 at age 17, he claimed to be a shoemaker. As all his relatives were peasants, it was unlikely that Biagio had learned to be a shoemaker and had mastered the trade at age seventeen. His uncle Giuseppe d'Arco had paid for his passage and Biagio was going to join him at 628 Ewing Street in Chicago. As several others were going to join their relatives at 628 Ewing Street, it was probably a crowded tenement in the slum area known as the Italian quarter. Biagio went back and forth between the two countries several times. He arrived in the United States again on 20 March 1920, this time arriving in Boston. The Italian Government had paid for his passage along with everyone else listed on ship passenger page and penciled in at the top was "all ex soldiers" which could not be totally accurate as there were also women and children on the list. This time Biagio, a laborer, was going to stay with his uncle Ambrosio d'Arco at 826 Miller Street in Chicago, and this time he was planning on staying permanently in the United States. He also claimed to have come to the United States in December 1915 and stayed in Illinois.

Biagio married **Carmela Friscone** on 31 October 1920 in Chicago, Cook, Illinois. ¹⁰⁴ Carmela was also from Acerra and arrived in New York on 19 October 1920 going to join her uncle, Giuseppe d'Arco who lived on Miller Street in Chicago. ¹⁰⁵ More accurate would be uncle-in-law after the marriage took place twelve days later. Biagio and Carmela's first child was born in Chicago, but the next two children were born in Acerra in

16. **Giuseppa aka Josephine**³ **d'Arco** (Gaetano¹, Giuseppe²) was born on 22 September 1907 at Acerra, Naples, Italy. ¹¹⁶ According to the 1920 census, she arrived in the United States in 1919, and while the 1930 census says she arrived in 1927, her Petition for Naturalization says she arrived on 5 September 1919 on the *S.S. Taormina*. ¹¹⁷ She appears on the ship manifest in 1919 with her mother and sister, Antonia (aka Antoinette), but a 1927 passenger record was not found. ¹¹⁸ She married Patsy, probably short for **Pasquale**, **Porcelli** on 6 July 1925 at Chicago, Cook, Illinois. ¹¹⁹ (See Document 2) She died on 3 January 1953 in Chicago, Cook, Illinois. ¹²⁰

Josephine was able to read and write having completed the 5th grade. ¹²¹ She married about three months before her 19th birthday and appears to have been a housewife. ¹²² The Great Depression began with the stock market crash in October 1929, four years after her marriage. According to the 1930 census taken April 8th, Josephine had a nine-month-old daughter and she and her husband were living in her father's home. ¹²³ Fortunately, her

husband and father were working for the city and her sister, Antoinetta, was working in a factory. ¹²⁴ By the 1940 census, Josephine and her husband had left Little Italy and were living on their own having bought a house at 2945 Arthington Street. ¹²⁵

Pasquale Porcelli died on 25 July 1945 in Chicago, Cook, Illinois, leaving Josephine with two children ages sixteen and fourteen. ¹²⁶ Apparently she married **Tony Datri** twice, once on 10 September 1949 and again on 11 January 1951 in Cook County, Illinois. ¹²⁷ When she died in 1953, she was again known as Josephine Porcelli. ¹²⁸

17. **Antonia aka Antoinette**³ **d'Arco** (Gaetano¹, Giuseppe²) was born on 12 February 1909 at Acerra, Naples, Italy. ¹³⁴ She immigrated to the United States on 5 September 1919 aboard the *S.S. Taormina*. ¹³⁵ Around the same time her father married Teresa (Falco) Amato, Antoinetta married Teresa's son, **Frank Amato**, on 9 January 1932 at Chicago, Cook, Illinois. ¹³⁶ (See Document 3) She died on 2 October 2005 at Cicero, Cook, Illinois. ¹³⁷

Antoinette was a member of St. Francs of Rome Church, 15th Street and 59th Court, Cicero, Illiois. ¹³⁸ She was a retired inspector for Arrco Playing Cards. Arrco (originally Arrow) was a subsidiary of the Regensteiner Corporation "a major colortype printing firm led by the inventor of the four-color lithograph press, Theodore Regensteiner" and Arrco cards were known for their quality in card stock and color. ¹³⁹ Arrow Playing Card Company was located at 800 S. Sibley Street "in Little Italy" before it relocated. ¹⁴⁰
